

Terms and Conditions Policy:

1. General Terms

- a. By accessing and using our website, you agree to comply with these terms and conditions.

2. Product Purchase and Refunds

- a. Our products are transferable power soft skills for the future, which can be purchased individually by individuals and businesses.
- b. Upon purchase, customers will receive 1 micro bite plus and one free eBook with credits to associated links and an infographic scroll.
- c. For those joining as members, purchasers will have access to over 100 micro-bite presentations via a protected learning and insights hub.
- d. Customers have the right to request a refund within 30 days of purchase on micro bite purchases and classes only. However, we reserve the right to refuse repeat purchases if we identify repeat refund requests.
- e. All memberships purchased prior to the new learning and management platform launch in 2025 will renew a year after purchase, notifications will be received. Membership cannot be refunded as the whole hub will be available immediately- for further explanation on why this is, please visit our membership terms and conditions on our policies page.
